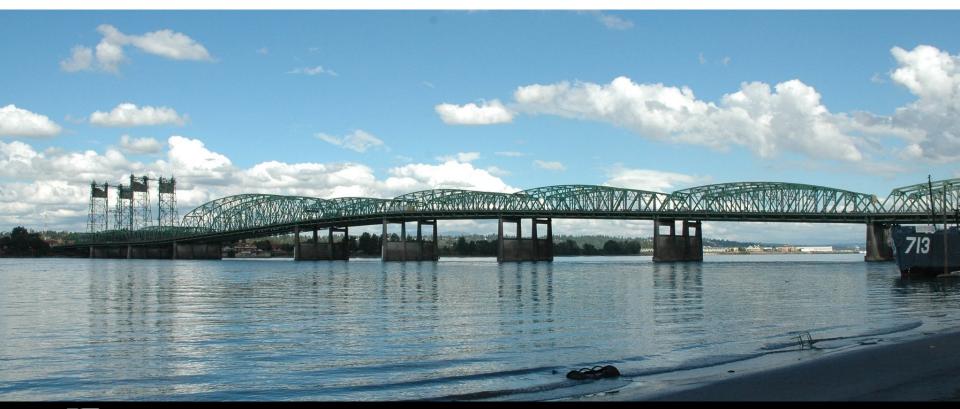


#### Introductions: Interim CAG Co-Chair Ed Washington

- Contributed to Metro's 2030 Regional Waste Plan, which was approved in March 2019

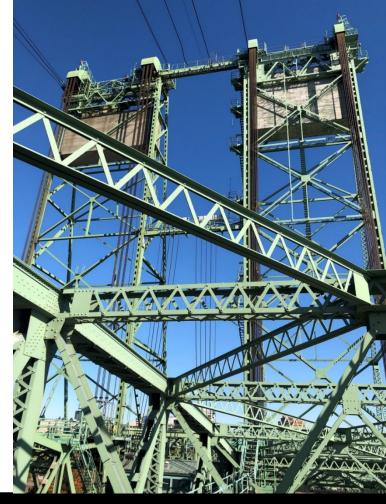

## Interstate Bridge Replacement Program Overview and Updates



#### Initiating a New Interstate Bridge Replacement Effort

Recent bi-state leadership has included:

- \$50 million in combined funding approved by OR and WA as of Sept. 2020
- Bi-State Memorandum of Intent signed by Governors Brown and Inslee Nov. 2019
- Bi-state legislative committee oversight and guidance to shape program work
- Federal Highway Administration repayment extension granted until Sept. 30, 2024

#### **Recent Bi-state Legislative Committee Meetings**



Each state legislature has identified eight members to provide direction and oversight to shape IBR program work

2020 meeting dates and highlight of presentation topics:\*

- July 16: Review of previous Purpose & Need and Vision & Values
- August 6: Initial guidance on community engagement; feedback on approach to develop Purpose & Need, Vision & Values, and finance plan
- October 1: Review of previous transit and river crossing alternatives analyses and approach to develop new transit and river crossing alternatives
- November and December committee meetings are anticipated

#### **General Engineering Consultant**

Following a competitive process, WSP was selected as the prime consultant in close partnership with Parametrix to provide specialized staffing resources to support program work

- The consultant team has committed to surpassing the mandatory 15%
   Disadvantaged Business Enterprise involvement goal, with a voluntary goal of 20%
- A Diversity Lead is tasked with ensuring the program is meeting or exceeding this goal

The team also includes a **Chief Equity Officer** to work across disciplines to ensure equity principles are embedded into the whole project

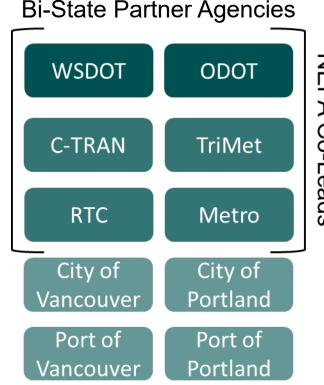
#### **Partnering Process**

Facilitated sessions to discuss how to work together to identify a solution that:

- Can build broad regional support
- Reflects community values
- Can successfully advance to construction

Recommended convening:

- Executive Steering Group to provide regional leadership recommendations
- Community Advisory Group to provide a forum for community dialogue



#### Value and Purpose of the Executive Steering Group

#### **Objective**

Guide IBRP program development such that it:

- Satisfies legislative requirements
- Is broadly supported by diverse stakeholder communities in the region
- Provides safe, healthy, reliable and affordable transportation that support access to jobs, education, culture and recreation
- Is viable for state and federal funding
- Can be successfully implemented

#### Value and Purpose of the Executive Steering Group

#### **Shared Expectations**

Work together collaboratively and constructively as regional partners

Work with communities to identify a solution with broad regional support

Provide thorough and expedient review of materials and transmittal of input

Model collaborative leadership in developing a viable funding package

Develop effective bi-state partnerships that could serve as foundation for future joint efforts to address regional issues



#### Value and Purpose of the Executive Steering Group

#### Value of Collaboration and Consensus

The ESG is being convened to develop and demonstrate broad regional support and recommendations from this group will be taken as regional leadership guidance for the program informed by the community

Community input and the guidance of representative governments and agencies in the region will be essential to decision-making and developing a project that has broad support

Consensus recommendations from the ESG will send a strong message to program leadership and are vital to success of the program

#### **IBRP ESG Draft Charter**

#### Purpose:

- The Charter outlines the charge and operating protocols for the Interstate
  Bridge Replacement Program (IBRP) Executive Steering Group (ESG) and
  clarifies the roles and responsibilities of the ESG throughout the IBRP
  process.
- The Charter is intended to create common expectations about how the ESG members will work together and puts an emphasis on clear communication, trust building, respect for divergent views, creative thinking, the pursuit of mutual goals, and authentic community engagement.

## **Equity Considerations**

#### **Key Objective**

 How do we ensure that equity is incorporated into all elements of the program?



#### **Considerations**

#### **Capacity**

Given all that the ESG and CAG will be tasked with, do they have the ability to give equity the focus it deserves?

#### **Expertise**

The CAG should be a diverse representation of the community. However, this does not necessarily mean members will be well-versed in transportation equity issues.

#### **Legitimacy & Intentionality**

The ESG has indicated that equity should be prioritized. How do we best demonstrate that this is the case?

#### **Buckets of Work**

- Equity assessment (existing policies and programs relative to equity at WSDOT, ODOT, TriMet, C-TRAN, Metro, RTC, City of Vancouver, City of Portland, Ports, other jurisdictional partners)
- Assessment of compliance and equity guidelines with relevant federal requirements and guidance (FTA, FHWA)
- Assessment of CRC equity work products (Community & Environmental Justice Group (CEJG), other work)

#### **Potential Work Program**

**Defining 'equity'** for IBR program

Defining desired outcomes and metrics to achieving this definition

Frame the **historical context** (e.g., tribal communities, I-5 construction, gentrification and displacement)

**Community engagement plan** (e.g., limited English proficiency (LEP), tactics, strategy, audience and approach)

Strategies to avoid, minimize, and/or mitigate adverse impacts

**Financing** options (e.g., any discussion regarding the need to means test revenue options to lessen impact on low income residents)

Review and input on design decisions of importance to the community

Disadvantaged Business Enterprise/On-the-Job Training (DBE/OJT) plans





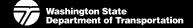
#### **Next Steps**

- Work with equity staff from partnering agencies to determine best approach to integrating equity in every aspect of the program, including developing a group to advise on program process and outcomes with an equity lens
- Work with agency equity experts to frame a plan to stand up this group by early 2021

#### **Community Engagement + CAG**

The CAG is one element of the planned **Strategic Communications and Public Engagement Plan** for IBR.

The Plan will include numerous opportunities for public input from a dynamic range of stakeholders and interests through a vast array of online tools and creative approaches to reaching stakeholders where they are as opposed to asking them to come to us.

#### **Key Characteristics of Community Advisory Group (CAG)**

- Representative of the community and reflective of regional needs, issues,
   and concerns as they relate to the IBR program
- Provide a forum for community dialogue and feedback on community needs, issues, concerns
- Serve to advise and provide recommendations to the ESG and IBR program team on key issues from a variety of community perspectives
- CAG Co-Chairs serve as members of ESG and representatives of the CAG

#### **CAG Charge**

- CAG will represent a broad range of regional constituent interests and will serve to advise and provide recommendations to the ESG, IBR program team, and future working groups on key issues from a community perspective
- Will exist throughout program development. The CAG charge will be reviewed and reconsidered when the program is nearing NEPA completion.
- Topical subgroups may be formed, as needed, to more fully explore specific subjects under the CAG's purview and will be sunsetted after the topic is addressed

#### **CAG Membership**

- Ensure a diverse range of perspectives, including identifying individuals that represent more than one interest.
- Establish a group aiming for approximately 25 members.
- 5 members at-large through an application process; other members selected through recruitment / nomination process.
- Around 80% of members will live in the Southwest Washington / Portland Metro Region with balanced representation from both Oregon and Washington.

### **CAG Membership, cont.**

- When members are selected, it will be clearly identified whether they are acting as an individual representative or on behalf of an organization.
- Organizations participating will have the opportunity to replace members if a
  member resigns by meeting the selection criteria. Organizations may
  designate an alternate if they can't attend a meeting but active participation by
  one representative is preferred
- Individuals that resign will be replaced through an application process.

### **CAG Eligibility Criteria**

Applicants should have demonstrated ability and commit to:

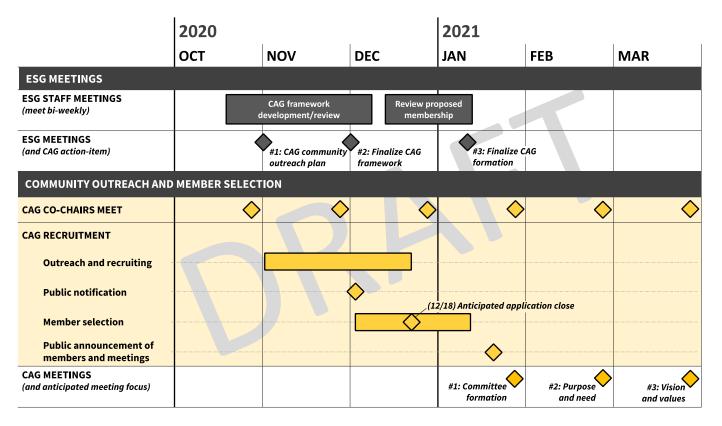
- Work together in a collaborative and constructive way to advance the best possible bridge replacement project for I-5
- Actively participate with a commitment to transparency
- Embrace transparency, equity, listening to understand, and active participation in meetings
- Seek solutions through consensus
- Create a two-way dialogue with constituents if representing a stakeholder group

### **CAG Eligibility Criteria, cont.**

Members could fall into multiple categories, but we will seek members who:

- Include frequent users of the existing Interstate Bridge
- Reflect communities of concern
- Those impacted directly by the project
- Create a balance of both states
- Represent our multigenerational community
