



## How to access closed captions



- 1. At the bottom middle of your screen, you should see a menu of options. If you can't see the menu, hover your mouse over the bottom middle of the screen.
- 2. Click the square "CC" icon towards the right side of the menu to toggle captions on.
- 3. Click the submenu ^ arrow to access more settings including language, font color and font size.





# **ASL Interpretation**

## **Community Benefits Advisory Group (CBAG)**

- ► The Community Benefits Advisory Group will develop recommendations for community benefit efforts. Recommendations aim to achieve the greatest positive benefit to the communities in the Program area and broader region.
- Within the scope of the IBR Program the CBAG will:
  - Apply the Community Values & Priorities developed by CAG to the CBAG recommendation development process
  - Advise IBR on how to leverage the Program's work and partnerships to achieve the greatest positive benefit to the communities in the Program area and broader region from the Program's work
  - Explore community benefits that align with community priorities
  - Advise IBR on the establishment of accountability mechanisms for commitments made in the CBAG process




### **CBAG Structure**

- Balanced representation from Oregon and Washington
- Includes representatives from EAG and CAG
- Co-conveners are Cities of Portland and Vancouver
- CBAG member "types" include:
  - Program area residents
  - Program area business owners
  - Workforce development
  - Housing
  - Culturally-specific CBOs and businesses
  - Disability rights
  - Environmental Advocates
  - Parks & Recreation

# **Key Themes from CBAG Discussions**

#### User experience

- Weather conditions, safety, shelter, viewpoints
- Accessibility
- Wayfinding, layout of the multi-use path, connectivity

#### Construction impacts

- Alternative routes, limiting closures, mitigation for noise and dust
- Proactive communication & resources for community to report impacts

#### Considerations for implementation of recommendations

- Cost analysis, funding options, partner collaboration
- Standard practices for DOTs, transit agencies, contractor requirements
- Ongoing operations and maintenance
- Alignment with MLPA/SEIS



# **Key Themes from CBAG Discussions**

#### Community voice

- Input from specific groups with lived experiences:
  - Multimodal transportation users
  - Individuals with disabilities
  - Consulting tribes

#### Environmental considerations

- Materials used in construction
- Greenspaces, naturalized landscaping, tree planting
- Incentives for contractors: EV charging, retrofitting diesel vehicles, etc.



# **CBAG Accomplishments**

- Collaborative & Community-Centered Process
  - Respectful iterative discussions
  - Sharing of lived experiences
- Achieved agreement from group with wide variety of perspectives, expertise, and interest areas
  - Voted four times using modified consensus
- Took a broad list of over 100 recommendations and refined them into 55 focused recommendations
  - Considered important factors for implementation

# **CBAG Recommendations Analysis**

#### Purpose:

- Thoroughly analyze the recommendations against considerations and decision factors to aid in informed decision-making by IBR & owner agencies
- Collect input from technical experts across disciplines

#### Key considerations of the analysis:


- Crossover with aspects of the Program
  - SEIS & mitigations, partner conditions, etc.
- Standard requirements/practices or within the scope of what agencies typically do
  - If outside of this, what would be required?
  - Example: long-term monitoring that would require partners to implement
- Responsible party & mechanism for implementation
- Potential funding sources
- Timing and decision-making
  - Key example: specific design details



# **CBAG Recommendations Analysis**

#### **Broad Considerations for Analysis**

- Alignment with standard practices or requirements
- Importance to community and advisory groups
- State Highway Fund eligibility
- Restrictions/allowances under major grants
- Risk
- Potential funding source
- Timeline urgency
- Need for inclusion in procurement documents, federal environmental documents, or 3rd Party Agreements
- Responsible party & mechanisms for implementation




#### **Specific Decision Factors**

- Budget feasibility
- Ease of implementation
- Level of impact on design
- Policy priority/outcome
